1. Introduction and aims

At Brierley CE Primary School we recognise that mobile phones, including smart phones, are an important part of everyday life for our pupils, parents/carers and staff, as well as the wider school community.

Our policy aims to:

- > Promote, and set an example for, safe and responsible phone use
- > Set clear guidelines for the use of mobile phones for pupils, staff, parents/carers and volunteers
- > Support the school's other policies, especially those related to child protection and behaviour

This policy also aims to address some of the challenges posed by mobile phones in school, such as:

- > Risks to child protection
- > Data protection issues
- > Potential for lesson disruption
- > Risk of theft, loss, or damage
- > Appropriate use of technology in the classroom

2. Roles and responsibilities

2.1 Staff

All staff (including teachers, support staff and supply staff) are responsible for enforcing this policy.

Volunteers, or anyone else otherwise engaged by the school, must alert a member of staff if they witness, or are aware of, a breach of this policy.

The head teacher is responsible for monitoring the policy every year, reviewing it, and holding staff and pupils accountable for its implementation.

2.2 Governors

Governors will monitor this policy annually

3. Use of mobile phones by staff

3.1 Personal mobile phones

Staff (including volunteers, contractors and anyone else otherwise engaged by the school) are not permitted to make or receive calls, or send texts, while children are present. Use of personal mobile phones must be restricted to non-contact time, and to areas of the school where pupils are not present.

There may be circumstances in which it's appropriate for a member of staff to have use of their phone during contact time. For instance:

- > For emergency contact by their child, or their child's school
- In the case of acutely ill dependents or family members
- > For medical needs ie waiting a callback form a medical practitioner

The headteacher will decide on a case-by-basis whether to allow for special arrangements.

If special arrangements are not deemed necessary, school staff can use the school office number 01226 711332 as a point of emergency contact.

3.2 Data protection

Staff must not use their personal mobile phones to process personal data, or any other confidential school information, including entering such data into generative artificial intelligence (AI) tools such as chatbots (e.g. ChatGPT and Google Bard).

3.3 Safeguarding

Staff must refrain from giving their personal contact details to parents/carers or pupils, including connecting through social media and messaging apps.

Staff must avoid publicising their contact details on any social media platform or website, to avoid unwanted contact by parents/carers or pupils.

Staff must not use their mobile phones to take photographs or recordings of pupils, their work, or anything else which could identify a pupil. If it's necessary to take photos or recordings as part of a lesson/school trip/activity, this must be done using school equipment.

3.4 Using personal mobiles for work purposes

In some circumstances, it may be appropriate for staff to use personal mobile phones for work. Such circumstances may include, but aren't limited to:

- > Emergency evacuations
- > Supervising off-site trips
- > Supervising residential visits

In these circumstances, staff will:

- > Use their mobile phones in an appropriate and professional manner, in line with our staff code of conduct
- > Not use their phones to take photographs or recordings of pupils, their work, or anything else which could identify a pupil
- > Refrain from using their phones to contact parents/carers. If necessary, contact must be made via the school office or the staff member must withhold their number

3.5 Sanctions

Staff that fail to adhere to this policy may face disciplinary action.

See the school's staff disciplinary policy for more information.

4. Use of mobile phones by pupils

- > Pupils may bring mobile phones to school if they are:
 - Travelling to school by themselves
 - Young carers who need to be contactable
 - Attending clubs after school and need to be contactable
- Any pupil who brings a mobile phone to school must store it with the class teacher on entry to school, in a in a secure location designated by the class teacher. The phone must not be used throughout he day and will be returned to the child at the end of the school day.
- > A mobile phone may be used by a child, at an allocated time, at the direction of the teacher for trips and visits.

Pupils must adhere to the school's Mobile Phone Code of Conduct for Pupils (see appendix 1).

4.1 Sanctions

If a pupil is in breach of this policy, it may result in the mobile phone being confiscated. Schools are permitted to confiscate phones from pupils under sections 91 and 94 of the <u>Education and Inspections Act 2006</u>)

- > If a phone is confiscated, permission will be given to a parent or carer to collect the phone. The phone can be collected from the school office at the end of the school day.
- > The school's behaviour policy will be adhered to, using the traffic light system.

Staff have the power to search pupils' phones, as set out in the <u>DfE's guidance on searching, screening and confiscation</u>. The DfE guidance allows schools to search a pupil's phone if they have reason to believe the phone contains pornographic images, or if it is being/has been used to commit an offence or cause personal injury.

Staff will refer to the Child Protection and Safeguarding Policy if harmful or illegal material is found.

Certain types of conduct, bullying or harassment can be classified as criminal conduct. The school takes such conduct extremely seriously and will involve the police or other agencies as appropriate.

Such conduct includes, but is not limited to:

- > Sexting (consensual and non-consensual sharing nude or semi-nude images or videos)
- Upskirting
- > Threats of violence or assault
- Abusive calls, emails, social media posts or texts directed at someone on the basis of someone's ethnicity, religious beliefs or sexual orientation

5. Use of mobile phones by parents/carers, volunteers and visitors

Parents/carers, visitors and volunteers (including governors and contractors) must adhere to this policy as it relates to staff if they are on the school site during the school day.

This means:

- > Not taking pictures or recordings of pupils, unless it's a public event (such as a school fair), or of their own child
- Using any photographs or recordings for personal use only, and not posting on social media without consent
- > Not using phones in lessons, or when working with pupils

Parents/carers, visitors and volunteers will be informed of the rules for mobile phone use when they sign in at reception or attend a public event at school.

Parents/carers or volunteers supervising school trips or residential visits must not:

- > Use their phone to make contact with other parents/carers
- > Take photos or recordings of pupils, their work, or anything else which could identify a pupil

Parents/carers or volunteers supervising trips are also responsible for enforcing the school's policy for pupils using their phones, as set out in section 4 above.

Parents/carers must use the school office as the first point of contact if they need to get in touch with their child during the school day. They must not try to contact their child on his/her personal mobile during the school day.

6. Loss, theft or damage

Pupils bringing phones to school must ensure that phones are appropriately labelled and are stored securely when not in use.

Pupils must secure their phones as much as possible, including using passwords or pin codes to protect access to the phone's functions. Staff must also secure their personal phones, as well as any work phone provided to them. Failure by staff to do so could result in data breaches.

The school accepts no responsibility for mobile phones that are lost, damaged or stolen on school premises or transport, during school visits or trips, or while pupils are travelling to and from school. This includes confiscated phones which will be stored securely in the school office.

Lost phones should be returned to the school office. The school will then attempt to contact the owner.

7. Monitoring and review

The school is committed to ensuring that this policy has a positive impact of pupils' education, behaviour and welfare. When reviewing the policy, the school will take into account:

- > Feedback from parents/carers and pupils
- > Feedback from teachers
- > Records of behaviour and safeguarding incidents
- > Relevant advice from the Department for Education, the local authority or other relevant organisations

Governors will monitor this policy annually.

8. Appendix 1: Mobile Phone use - Code of conduct for pupils

You must obey the following rules if you bring your mobile phone to school:

- 1. You may not use your mobile phone during lessons, unless the teacher specifically allows you to.
- 2. Phones must be switched off (not just put on 'silent').
- 3. You may not use your mobile phone in the toilets or changing rooms. This is to protect the privacy and welfare of other pupils.
- 4. You cannot take photos or recordings (either video or audio) of school staff or other pupils without their consent.
- 5. Avoid sharing your contact details with people you don't know, and don't share other people's contact details without their consent.
- 6. Don't share your phone's passwords or access codes with anyone else.
- 7. Don't use your mobile phone to bully, intimidate or harass anyone. This includes bullying, harassing or intimidating pupils or staff via:
 - a. Email
 - b. Text/messaging app
 - c. Social media
- 8. Don't use your phone to send or receive anything that may be criminal. For instance, by 'sexting'.
- 9. Rules on bullying, harassment, and intimidation apply to how you use your mobile phone even when you aren't in school.
- 10. Don't use vulgar, obscene or derogatory language while on the phone or when using social media. This language is not permitted under the school's behaviour policy.
- 11. Don't use your phone to view or share pornography or other harmful content.
- 12. You must comply with a request by a member of staff to switch off, or hand over, a phone. Refusal to comply is a breach of the school's behaviour policy and will be dealt with accordingly.
- 13. Mobile phones are not permitted in any internal or external exam or test environment. If you have a mobile phone, you will be asked to store these appropriately, or turn them over to an exam invigilator, before entering the test room. Bringing a phone into the test room can result in your exam being declared invalid.

Pupil agreement

I understand that I am being allowed to bring my phone to school.

I will not use my phone at any time during the school day unless I am permitted to do so by my teacher.

If my teacher, or any other member of staff, finds that I'm using my phone, I understand that it will be confiscated.

I understand that the school's code of conduct on the use of mobile phones applies.
